

[A.1] Introduction

We the members, Of the nation of Blazed, assemble this body of government, both for the collective advancement of the society which supports it, and for the individual enrichment to all those who comprise it, under the parameters established henceforth in this constitution.

[A.2] Governance

The enforcement of all codes and regulations established in the Blazed Code of Laws (B#2) shall be handled by the Departments of Governance (A.3). All officially released documents, to be amended to the Blazed Constitution, must have been published by: Blazed Labs LLC, and shall bear a numbered document identity bearing the format: "B#N", where "N" is the numbered document identity, as set forth by Blazed Labs LLC. All ties or deadlocks reached by the Departments of Governance, wherein a mediation cannot be reached, the tie shall be broken by Blazed Labs LLC.

[A.3] Departments

The Departments of Governance, as established by Blazed Labs LLC, shall be divided as follows: Business, Labor, Industry, Real Estate, and Distribution. Each department shall be represented in the nation of Blazed by a company appointed by Blazed Labs LLC. Each department shall appoint a chairman, vice-chairman, and a delegate of the people. Each department may also appoint other representatives, but are not required to do so. All appointments of power shall be arranged by the appointed standing chairman of the department to which the appointment is to occur. If the appointment is of a chairman, the arrangements for said appointment shall be made by the governing body of the nation of Blazed. All governing bodies, including the Departments of Governance, are to uphold the law as set forth in this constitution (B#1) and in the Blazed Code of Laws (B#2). All departments are to maintain a public website for service access.

[A.4] Business

All business conducted within the virtual boundaries of the nation of Blazed (as defined by A.7 of this document) shall be conducted within the parameters of the Blazed Code of Laws (B#2) and shall be done so under the jurisdiction of the Department of Business. All business transactions, conducted within the jurisdiction of the Department of Business, shall be finalized by a contract signed by all parties involved. The contract format should reflect the format set forth by the Department of Business. All citizens of Blazed have the right to found a business. Any business, which wishes to register to conduct business in Blazed, must first hold a Business Permit, as issued by the Department of Business.

[A.5] Labor

All labor performed within the virtual boundaries of the nation of Blazed (as defined by A.7 of this document) shall be conducted within the parameters of the Blazed Code of Laws (B#2) and shall be done so under the jurisdiction of the Department of Labor. All citizens of the nation of Blazed, have the right to perform labor, given the labor is performed within the parameters set forth by the Blazed Code of Laws (B#2). Before any labor is performed, all involved parties should sign a contract (bill of work), this bill of work shall include the details about the work that is to be performed, such as total payment to the laboring party, as well as the employer's definition of "done", to constitute the completion of a job. Upon completion of the job, given the proper conditions for "done" are met, the laboring party is legally, under Blazed Doctrine B#1, required to pay (in the full amount) the agreed upon payment. It is the responsibility of the Division of Labor to ensure all citizens who work in Blazed are fairly compensated for their work.

[A.6] Industry

All production of goods, performed within the virtual boundaries of the nation of Blazed (as defined by A.7 of this document) shall be conducted with headence to the parameters of the Blazed Code of Laws (B#2) and shall be done so under the jurisdiction of the Department of Industry. The Department of Industry reserves the right to impose taxation upon industrial activities, including, the production of goods, the storage of goods, the recycling of goods, and the refinement of goods. The Department of Industry, however, is commanded to work with mind to the safety of the populous which inhabits the nation of Blazed. All goods produced within the virtual boundaries of the nation of Blazed (as defined by A.7 of this document) shall be the sole property of the company who produced it.

[A.7] Real Estate

All land contained in the nation of Blazed, consisting of all unique namespaces under the public internet domain: <https://blazed.city/> This land is hereby claimed by Blazed Labs LLC. A page under this domain shall be referred to as a plot. Each plot shall be the sole property of the current legal deed holder. The deed shall be drawn to prove ownership, and amended to reflect new owners if the land shall be sold. A bill of sale with signature(s) from the owner of the property to transfer ownership.

[A.8] Distribution

All distribution of goods performed within the virtual boundaries of the nation of Blazed (as defined by A.7 of this document) shall be conducted within the parameters of the Blazed Code of Laws (B#2). For items to be distributed in Blazed, they must be placed in vehicles. All vehicles which operate in the nation of Blazed shall be registered.

[A.9] Population

The population of the nation of Blazed shall be composed of all members of the Blazed Client site, as well as all AI. To become a citizen of the nation of Blazed, one must register and receive an entity ID. All people in Blazed have the right to defend themselves.

[A.10] Property and Ownership

All citizens and businesses within the nation of Blazed have the right to own goods, bonds, accounts, currency, vehicles, properties, and businesses. Ownership from good to entity may be assigned through a legal deed. For the ownership of goods to be transferred, such as through sale of those goods, there must be a bill of sale, signed by all parties involved, which truthfully reflects the total amount exchanged for the goods.
